TERMS AND CONDITIONS

1. Introduction

Welcome to **His Residency Sir Brian** (“Company”, “Business”, “we”, “our”, “us”)!

These Terms of Service (“Terms”, “Terms of Service”) govern your use of our website located at **mysafaricost.com** (together or individually “Service”) operated by **His Residency Sir Brian**.

Our Privacy Policy also governs your use of our Service and explains how we collect, safeguard and disclose information that results from your use of our web pages.

Your agreement with us includes these Terms and our Privacy Policy (“Agreements”). You acknowledge that you have read and understood Agreements, and agree to be bound of them.

2. What services are provided at MySafariCost.com?

MySafariCost.com, which is a product of our Company offers digital marketing services in the tourism sector for tour operators, hotels and tourist destinations. These services are provided online only, as automated on www.mysafaricost.com, and no service is offered over the counter at any physical office. Please also note that our company doesn't at all work on your website or other digital materials like mobile app, print media or websites to enable delivery of her digital marketing services; all work is initiated and conducted solely on www.mysafaricost.com .

The service entails:

- a). A Set up of the client profile on mysafaricost.com at a one off fee of Ksh. 100 payable upfront after all information is collected and before the account setup. This fee is non-refundable and non-recurring.
- b). When above is fully setup (normally within 3 to 5 business days), we begin the marketing work and bill the client 3% of the total of every service booked from our end and paid to the client. This amount is invoiced and due immediately the first payment is received by our client from that sale specific.
- C). All marketing digital marketing services will be paused as soon an invoice is due for payment and resumed immediately all due invoices are fully paid.

3. Communications and service provision
